Alondra Orozco, the Kappa Delta delegate moves to approve the Bylaw Revision Proposal to be voted upon May 1st. Seconded by Avery LeBlanc, Alpha Gamma Delta delegate.

Current Bylaw:

DISASSOCIATION: All chapters and members shall support the Rho Gammas and the CPA Executive Board in their efforts to disassociate.

DISASSOCIATION: Rho Gammas and CPA Executive Board must begin to disassociate from their chapters on a digital presence beginning July 1st prior to fall semester. Hard dissociation begins August 1st and encompasses the following:

1. Disassociation includes not wearing sorority or fraternity paraphernalia and the removal of sorority decals and other items from visibility.
2. Rho Gammas and CPA Executive Board may not reveal their affiliation verbally, explicitly or implied.
3. Rho Gammas and CPA Executive Board shall not be in contact with any members of any chapter, including her own.
4. Rho Gammas and CPA Executive Board must “deactivate” their presence on any public media, social media, or websites.

- a. This means social media accounts must be set to private modes.
 - i. Additionally, it is best practice to follow all nine of SDSU's Panhellenic chapter Instagram accounts or to be following none at all.
- 5. Rho Gammas and CPA Executive Board shall not discuss recruitment, especially related to a PNM, with anyone except other Rho Gammas, CPA Executive Board or the Fraternity & Sorority Advisory Team.
- 6. Rho Gammas and CPA Executive Board shall not encourage PNMs to guess the Rho Gammas chapter or partake in similar conversations.

Proposed Bylaw Change:

DISASSOCIATION: All chapters and members shall support the Rho Gammas in their efforts to disassociate.

- i. **DISASSOCIATION:** Rho Gammas must begin to disassociate from their chapters on a digital presence beginning July 1st prior to fall semester. Hard dissociation begins August 1st and encompasses the following:
 - 1. Disassociation includes not wearing sorority or fraternity paraphernalia and the removal of sorority decals and other items from visibility.
 - 2. Rho Gammas may not reveal their affiliation verbally, explicitly or implied.
 - 3. Rho Gammas shall not be in contact with any members of any chapter, including her own.
 - 4. Rho Gammas must "deactivate" their presence on any public media, social media, or websites.
 - a. This means social media accounts must be set to private modes.
 - i. Additionally, it is best practice to follow all eight of SDSU's Panhellenic chapter Instagram accounts or to be following none at all.
 - 5. Rho Gammas and CPA Executive Board shall not discuss recruitment, especially related to a PNM, with anyone except other Rho Gammas, CPA Executive Board or the Fraternity & Sorority Advisory Team.
 - 6. Rho Gammas shall not encourage PNMs to guess the Rho Gammas chapter or partake in similar conversations.

DISASSOCIATION: All chapters and members shall support the CPA Executive Board in their efforts to soft disassociate.

- ii. **DISASSOCIATION:** CPA Executive Board must begin to disassociate from their chapters on a digital presence beginning

July 1st prior to fall semester. Soft disassociation is enforced August 1st and encompasses the following:

1. Disassociation includes not wearing sorority or fraternity paraphernalia and the removal of sorority decals and other items from visibility.
2. CPA Executive Board and their chapter must not post any new presence involving their chapter on any public media, social media, or websites
 - a. This means social media accounts must be set to private modes.
 - i. Additionally, it is best practice to follow all eight of SDSU's Panhellenic chapter Instagram accounts.
 - ii. CPA Executive Board shall not discuss recruitment, especially related to a PNM, with anyone except other Rho Gammas, CPA Executive Board or the Fraternity & Sorority Advisory Team.
 - iii. CPA Executive Board will leave/be removed from any group chats where Recruitment is discussed, starting the first day of school, and ending on Bid Day, not including the removal of academic or campus safety-related group chats.
3. CPA Executive Board shall not encourage PNMs to guess the Rho Gammas chapter or partake in similar conversations.
